

**Section 1**  
**TERMS AND CONDITIONS APPLICABLE TO THE GOODWOOD ROAD RACING COMPANY LIMITED "2024 FESTIVAL OF SPEED PRESENTED BY MASTERCARD QUIZ" PRIZE DRAW**
