

The Kennels Member Booking Incentive Terms & Conditions 2026

1. Incentive Period

1.1 This promotion (the “**Incentive**”) is valid for bookings made between **1 April 2026 and 30 November 2026** inclusive (the “**Incentive Period**”).

1.2 Bookings made outside the Incentive Period will not qualify.

2. Eligibility

2.1 The Incentive is open to all individuals holding an active membership with any Goodwood Membership Club, including The Kennels, Goodwood Motor Circuit, Goodwood Racecourse, the Goodwood Health Club, and any other membership scheme administered by the Goodwood Estate from time to time (each a “**Member**” and together the “**Members**”).

2.2 To qualify, Members must quote the promotional code **KENNELS26** at the time of booking.

2.3 For the purposes of this Incentive, a “**Booking**” means a booking made by a Member for the private hire of all or part of The Kennels with a minimum booking fee of £1,500 (excluding VAT and food and beverages).

2.4 Only Bookings that are made and fully confirmed within the Incentive Period will be eligible.

2.5 The Incentive applies only to Bookings taking place between 1 April 2026 and 30 November 2026.

2.6 The Incentive is limited to Bookings made by a Member; bookings made by third parties on behalf of the Member do not qualify unless otherwise agreed by Goodwood in writing.

3. Exclusions

3.1 Bookings on Estate Event dates or The Kennels Event dates (as published by Goodwood at <https://www.goodwood.com/whats-on/>) are excluded.

3.2 The Incentive does not apply to any Bookings made prior to 1 April 2026, regardless of event date or subsequent amendments.

4. Incentive Reward

4.1 For each eligible Booking, the Member will receive one (1) complimentary three-course lunch or dinner for two people at The Kennels (food only).

4.2 Drinks, service charges, gratuities, and any additional items are not included and will be chargeable at standard rates.

4.3 No multiple or combined rewards will be issued for the same Booking.

5. Reward Issuance and Redemption

5.1 The reward will be issued only once the relevant Booking is fully confirmed and an email confirmation has been sent by Goodwood to the Member.

5.2 The reward must be redeemed by 30 November 2026.

5.3 Reservations to redeem the reward are subject to availability.

5.4 Standard Kennels booking conditions apply to reward redemptions.

6. Non-Transferability

6.1 The reward is non-transferable, non-refundable, and cannot be exchanged for cash, credit, or any other alternative.

6.2 Goodwood reserves the right to request proof of Membership at the time of redemption.

7. Cancellations

7.1 If a Booking that generated a reward is cancelled for any reason, the associated reward will be void and may not be used.

7.2 Goodwood reserves the right to withdraw the reward if it reasonably suspects misuse or breach of these Terms & Conditions.

8. Amendments and Withdrawal

8.1 Goodwood reserves the right to amend, suspend, or withdraw the Incentive (in whole or in part) at any time without prior notice.

8.2 Any such amendments will not affect rewards already issued in accordance with these Terms & Conditions.

9. General

9.1 Participation in the Incentive constitutes acceptance of these Terms & Conditions.

9.2 Goodwood's decision on all matters relating to the Incentive is final.

9.3 This Incentive is administered by The Goodwood Estate Company Limited, whose registered office is Goodwood House, Goodwood, Chichester, West Sussex, PO18 0PX.

9.4 These Terms & Conditions are governed by and interpreted in accordance with the laws of England and Wales, and the courts of England and Wales shall have exclusive jurisdiction.
