

**TERMS AND CONDITIONS APPLICABLE TO
GOODWOOD RACECOURSE HOSPITALITY SURVEY PRIZE DRAW**

The terms and conditions set out in this section apply to all of the competitions and draws operated by the Goodwood Group. Additional Terms and Conditions are included in Section 2.

1. WHO IS PROMOTING/SPONSORING THIS COMPETITION?

2. CAN I ENTER?
